1. In accordance with clause 52.216-22 (b), Indefinite Quantity (designator I71), the guaranteed minimum and maximum dollar amounts for this procurement will be calculated as follows:

a. Minimum Contract Value. The minimum contract value is defined as the guaranteed monetary value of the aggregate orders issued during the base period only. The minimum will not guarantee orders for any particular item or group of items. The Government will not guarantee a minimum for the option periods.

The Government will compute a different minimum for each contract awarded under this solicitation, in accordance with the following formula:

10% of the aggregate of the extended dollar value of the minimum order quantity (MOQ) for the NSNs, computed as follows:

$10\% \times [\text{NSN1 price} \times \text{MOQ}] + [\text{NSN2 price} \times \text{MOQ}] + [\text{NSN3 price} \times \text{MOQ}] + \text{etc.}$

b. Maximum Contract Value. The maximum contract value is defined as 200% of the aggregate of the extended dollar value of the estimated value of the base period or each option period.

2. Contractors are directed to the solicitation's Pricing Workbook to obtain minimum order quantities referred to in clause 52.216-19, Order Limitations (I67).

3. The following sentence is deleted from Section 4.1 of the Statement of Work: "Sources of supply not approved by the ESA to manufacture critical items must submit required documentation to the ACO to obtain ESA approval prior to Government acceptance of those manufactured parts."

In accordance with clause L54, 52.217-9002, Conditions for Evaluation and Acceptance of Offers for Part Numbered Items (L54), items will only be awarded for source-approved items. Offers of items not approved (i.e., alternate offers) must be accompanied by technical data packages, as specified in the clause.

4. Please note that this solicitation is FOB Origin. Clauses related to FOB Destination are deleted.
